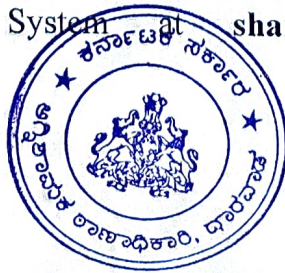

As per the report submitted by the Fire Station Officer, Dharwad, The Installation of the Fire Fighting System at shantesh education society's



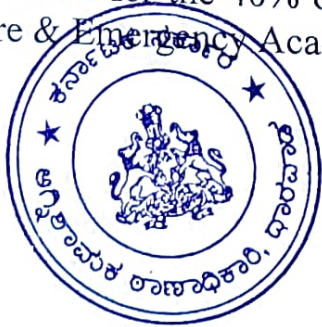
Smt.V.P.Hanchinmani International school Attikolla kalaghatagi road dharwad.is satisfactorily accepted the training part should do within 03 months.
